



Monthly Business Meeting - Summary of Minutes

(Detailed minutes, recorded by the clerk, are located in the Secretary's Office)

The Monthly Business Meeting was held on **September 10, 2014**. (1) Bro. Steve reported that the Women's lunch has been moved to October 25th after being postponed on September 6th due to the death and funeral of Sam Farris. There are approximately 150 women signed up to participate. He reported that they received notification that the Jefferson Street Center has been renamed to Louisville Rescue Mission which identifies their location and service a little better. On October 12th "Brotherhood", a black men's choir, will be performing at 6:00 p.m. in the Sunday Evening Service. (2) Larry Bright, the new Chairman of the Deacons, reports they met for their regular meeting and elected officers. Dennis Wise will be serving as Vice-Chairman, Josh Veatch as Secretary, and Steve Morris will serve as Assistant Secretary. (3) The History Committee is continuing preparation for the upcoming 140th Anniversary Celebration on November 9th. Josh England and Kaylene Poff video-taped several members about their memories and it will be shown at the conclusion of the event. Joan Stansbury has accepted the invitation to be the guest speaker, Bro. Steve Skaggs will be speaking and singing an assortment of past and present songs. There will be a Thanksgiving potluck meal, including chicken and ham, and the youth and AWANA children will be participating. The theme for this event is "Giving Thanks: For the Past, Present, and Future!" (4) David England, representing the Elevator Committee, reports that due to new state requirements, there has to be special inspections by a Testing Agency which will cost an unexpected additional amount of \$2,500. The drawings had to be revised by the architect and presented for approval by the state. The plans have been approved for the fabrication of the elevator. The Testing Agency, located in Bowling Green, will do inspections at 4 different times during the process of installing the elevator (5) Bob Moore, representing the Parsonage Committee, reports that they had several recommendations of remodeling by several members in the suggestion box. They will give a report to the next Business Meeting regarding the plans and bids based on these recommendations. (6) In New Business, Bro. Steve reports that the Central Association Meeting is scheduled for October 6th at Bradfordsville Baptist Church at 3:30 p.m. Four members were nominated, voted on and approved to be messengers of Muldraugh Hill Baptist Church. They are Arlene Mullins, Josephine Holderman, Elizabeth Farmer, and Bro. Steve Skaggs. (7) Also, in New Business, Larry Bright made a motion for the deacons that a new committee be formed to look into expanding the church parking lot and re-surfacing the existing blacktop. It was voted on and

approved. As a continuation of this, the following people were nominated to serve on the committee and were approved as follows: Tom Moore, Bob Moore, Burnam Lanham, and Dennis Wise. In discussion, it was suggested that the blacktop not be done until after the elevator is installed so the big trucks will not damage the area.
